

Terms of Use

These Terms of use of apply to this website (the “Site”) and certain associated sites linked to the Site (“Associated Sites”). The Site and the Associated Sites are sometimes referred to collectively as the “Sites”.

The Site Terms of Use – Acceptance of the Terms of Use

Welcome to this Site maintained by the Agricultural Finance Support Facility (“AGRIFIN”) (for purposes of these terms and conditions, the International Bank for Reconstruction and Development, also known as the World Bank, is acting for and on behalf of the AGRIFIN).
